<u>Important reminder for FD/FSS participants</u> The current fiscal year ends June 30, 2022. If you or a family member receives a Family Driven/Family Support Services (FD/FSS) allocation, there are deadlines to submit vouchers/invoices to Easter Seals.

Northampton County FSS participant vouchers: 4:30 PM Friday, July 15.

Lehigh County FSS participant invoices: 4:30 PM Friday, July 15.

Only vouchers/invoices for services or purchases made within the last 6 months can be reimbursed. You can mail or personally deliver invoices to Easter Seals, 1501 Lehigh Street, Allentown, PA 18103.

Post Mark cannot be used to document cooperation with the deadlines.

Dear Families, Friends and Colleagues:

Summer is coming and so is the state budget for 2022-2023. As stated in the <u>2022-23 Budget in Brief</u>, this year's budget proposes to move 732 individuals with an intellectual disability and/or autism from the emergency waitlist into the Community Living waiver and 100 individuals into the Consolidated Waiver.

The budget also includes a proposal that the Department of Human Services (DHS) invest in increased provider rates and program enhancements that will allow individuals to live safely in their community. In response to the pandemic-related staffing shortages and opportunities provided by these federal funds,

DHS refreshed rates for providers of developmental disabilities services, including a built-in minimum hourly wage assumption of \$15 an hour for a worker with a high school diploma.

The budget proposal includes a \$1.55 billion increase in basic education and a \$200 million increase in Special Education Funding.

As always, the budget goes through changes between now and when it is finally approved. The best way to determine how next year's budget might affect you, your family, and people you support, is to stay informed and to let your state representatives know what is important.

# **Lehigh County FD/FSS**

If you or someone in your family participates in the Lehigh County Family Driven/Family Support (FD/FSS) program, you will receive information for the upcoming fiscal year soon. The new fiscal year starts July 1, 2022 and goes through June 30, 2023.

#### Fiscal Year End Deadline

- The deadline for Lehigh County FD/FSS invoices from January 1 through June 30, 2022 is July 15. Invoices must be delivered to Easter Seals by 4:30 PM. Call Easter Seals at 610-289-0114 if you have questions about office hours, bad weather or holiday closures.
- Allocations for each participant will be renewed through the ISP process. Participants will received confirmation and the new year's guidelines in the mail and through email.
- Invoices submitted more than 180 days after the service or purchase cannot be paid.

#### **Important Features**

- 1) Participants have access to their entire allocation throughout next fiscal year.
- 2) Occasionally participant's families ask who is eligible to provide Family Aide and Respite service. Here are basic requirements:
  - Family Aide and Respite services cannot be provided by anyone living at the same address as the FD/FSS participant.
  - Family Aide and Respite services can be provided by family members.
  - Family Aide service can be provided by someone age 14 or over as long as they do not live with the participant.
  - Respite service can be provided by someone age <u>18 or over</u> as long as they do not live with the participant.
- 2. Funds left over from one fiscal year do not carry over to the next year.
- 3. Receipts for items purchased must accompany all invoices, except for family aide and respite services. A contact person or the FD/FSS participant must sign every invoice.
- 4. Respite and family aide providers are paid directly by Easter Seals. The IRS considers all income related to providing family aide or respite service reportable income.
  - → Providers of family aide and respite service must sign each invoice and provide a social security number.
  - → Activity logs must accompany invoices for respite and family aide services.
  - → If a family aide or respite provider earns more than \$600 in the calendar year, Easter Seals will send them a 1099 form showing earnings for income tax.
  - → If a provider earns less than \$600 in a calendar year, they are responsible to report the income.
- 8) Request for Innovative Service: If you need services beyond normal limits of the FD/FSS program (like family aide service more than 4 times in a month), you will need an approved request for innovative service.
  - → Contact your Support Coordinator to begin the process for innovative service requests.
  - → Requests for innovative services must be reviewed and approved before you make a purchase or use a service.
  - → There is no guarantee requests for innovative services will be approved. Each request is reviewed individually and may be approved or denied, based on the regulations.
- 9) <u>Appeals</u>: Lehigh County Intellectual Disabilities Program developed a process to make an appeal when a request or invoice is denied. You can access the appeals process through your supports coordinator.

# **Northampton County FD/FSS**

If you or someone you support patriciates in the Northampton County Family Driven/Family Support (FD/FSS) program, please take note of the following information.

#### **Program Enrollment**

The new fiscal year starts July 1, 2022. Participants are enrolled in Northampton County's FD/FSS program through their Supports Coordinator. FD/FSS funding is written into each participant's ISP.

#### **Important Features**

- A contact person or the FD/FSS participant must sign every voucher.
- Any unused funds from Fiscal Year 21-22 do not carry over to the 22-23 fiscal year.
- Eligible services include: Recreation, Respite, Family Aide, Family Education, and Camp.
- Request for Innovative Service: To use services beyond normal limits of the FD/FSS program, you will need an approved request for innovative service. Contact your Support Coordinator to begin the process for requests for innovative service.
- Requests for innovative services must be reviewed and approved before you make a purchase or use a service.
- There is no guarantee requests for innovative services will be approved. Each request is reviewed individually and may be approved or denied, based on the regulations.

#### FD/FSS program limitations

- FD/FSS funds may not be utilized to purchase gift cards of any type.
- People who live at the same address as the individual receiving supports cannot be paid to provide respite or family aide services.
- Easter Seals cannot pay vouchers received more than 180 days (6 months) past the date of purchase or service.
- Receipts for allowable items purchased must accompany all vouchers, except for family aide and respite services. Activity logs must accompany vouchers for respite and family aide services.
- Respite and family aide caregivers are paid directly by Easter Seals. Caregivers must sign and provide their Social Security Number on each voucher for those services.

#### **Deadlines**

- The deadline to submit vouchers from January 1 through June 30, 2022 is July 13, 2022. Vouchers must be delivered to Easter Seals by 4:30 PM.
- Individuals may request transferring funds to the second half of the fiscal year (1/1/2023-6/30/2023).
- Requests to move first half-year funds to the second half need to be made to Supports Coordinators by November 15, 2022 for carryover consideration.
- The deadline to submit vouchers from July 1, 2022 through December 31, 2022 is January 13, 2023.
- To observe deadlines, vouchers must be received by the Easter Seals office during normal business hours Monday Friday 8:30 AM 4:30 PM—except holidays or other office closures. Call Easter Seals office at 610-289-0114 if you have questions about office hours, bad weather or holiday closures.
- Invoices are accepted into Easter Seals based on the date they arrive in the office. Families can mail vouchers; a postmark will not be used to determine cooperation with deadlines.

Contact the FD/FSS program participant's Support Coordinator for questions, assistance with invoices or to make a Request for Innovative Service.



### **News To Use**

#### Outsmarting Poison Ivey and Other Poisonous Plants

Spending more time outdoors, no that Spring is here? Help you and your loved ones avoid the "not so great outdoors"

irst comes the itching, then a red rash, and then blisters. These symptoms of poison ivy, poison oak, and poison sumac can emerge any time from a few hours to several days after exposure to the plant oil found in the sap of these poisonous plants. The culprit: the urushiol oil. Here are some tips to avoid it.

#### Recognizing Poison Ivy, Poison Oak, and Poison Sumac

→ Poison Ivy: Found throughout the United States except Alaska, Hawaii, and parts of the West Coast. Can grow as a vine or small shrub trailing along the ground or climbing on low plants, trees and poles. Each leaf has three glossy leaflets, with smooth or toothed edges. Leaves are reddish in spring, green in summer, and yellow, orange, or red in fall. May have greenish-white flowers and whitish-yellow berries.



- → Poison Oak: Grows as a low shrub in the Eastern and Southern United States, and in tall clumps or long vines on the Pacific Coast. Fuzzy green leaves in clusters of three are lobed or deeply toothed with rounded tips. May have yellow-white berries.
- → Poison Sumac: Grows as a tall shrub or small tree in bogs or swamps in the Northeast, Midwest, and parts of the Southeast. Each leaf has clusters of seven to 13 smooth-edged leaflets. Leaves are orange in spring, green in summer, and yellow, orange, or red in fall. May have yellow-greenish flowers and whitish-green fruits hang in loose clusters.

#### Poison Plant Rashes Aren't Contagious

Poison ivy and other poison plant rashes can't be spread from person to person. But it is possible to pick up the rash from plant oil that may have stuck to clothing, pets, garden tools, and other items that have come in contact with these plants. The plant oil lingers (sometimes for years) on virtually any surface until it's washed off with water or rubbing alcohol.

The rash will occur only where the plant oil has touched the skin, so a person with poison ivy can't spread it on the body by scratching. It may seem like the rash is spreading if it appears over time instead of all at once. But this is either because the plant oil is absorbed at different rates on different parts of the body or because of repeated exposure to contaminated objects or plant oil trapped under the fingernails. Even if blisters break, the fluid in the blisters is not plant oil and cannot further spread the rash.

#### **Tips for Prevention**

Learn what <u>poison ivy</u>, <u>oak</u>, <u>and sumac plants look like</u> so you can avoid them (<u>watch our videoExternal Link</u> Disclaimer).

→ Wash your garden tools and gloves regularly. If you think you may be working around poison ivy, wear long sleeves, long pants tucked into boots, and impermeable gloves.

## **News To Use**

- → Wash your pet if it may have brushed up against poison ivy, oak, or sumac. Use pet shampoo and water while wearing rubber gloves, such as dishwashing gloves. Most pets are not sensitive to poison ivy, but the oil can stick to their fur and cause a reaction in someone who pets them.
- → Wash your skin in soap and cool water as soon as possible if you come in contact with a poisonous plant. The sooner you cleanse the skin, the greater the chance that you can remove the plant oil or help prevent further spread.

#### **Tips for Treatment**

Don't scratch the blisters. Bacteria from under your fingernails can get into them and cause an infection. The rash, blisters, and itch normally disappear in several weeks without any treatment.

You can relieve the itch by:

- → Using wet compresses or soaking in cool water.
- → Applying over-the-counter (OTC) topical corticosteroid preparations or taking prescription oral corticosteroids.
- → Applying topical OTC skin protectants, such as zinc acetate, zinc carbonate, zinc oxide, and calamine dry the oozing and weeping of poison ivy, poison oak, and poison sumac. Protectants such as baking soda or colloidal oatmeal relieve minor irritation and itching. Aluminum acetate is an astringent that relieves rash.



#### See a doctor if:

- → You have a temperature over 100 degrees Fahrenheit.
- → There is pus, soft yellow scabs, or tenderness on the rash.
- → The itching gets worse or keeps you awake at night.
- → The rash spreads to your eyes, mouth, genital area, or covers more than one-fourth of your skin area.
- → The rash is not improving within a few weeks.
- → The rash is widespread and severe.
- → You have difficulty breathing.
